ART in the PARK is an annual juried art event sponsored by the Artists' Group of Charlestown.

ART in the PARK 2017 will be held in the award winning City Square Park, Charlestown, MA on Saturday, September 9<sup>th</sup>, 2017 (rain date Sunday, September 10<sup>th</sup>).

Since 1998, ART in the PARK has consistently attracted talented artists from the New England area and beyond, becoming an extremely popular fine art event.

## Event and Participant Information:

The Committee will review and accept applicants based on creativity, originality of the work, presentation and medium of original work only including acrylic, oil, mixed media and watercolor painting, original prints and/or limited editions prints, photography, sculpture, glass and pottery, jewelry, fabric, textile or clothing design and other fine arts mediums. We will reserve the right to limit exhibitors in any one medium

- Space within the Park is limited to 65 artists.
- Exhibition space of 10 feet by 10 feet per artist.
- All set up, tear down, display materials and clean-up are the exhibitor's responsibility.
- Not all tents and/or canopies are suitable to the park venue and if used, all sidewalls must remain open. (Please provide your own weights to secure your panels/tents in case of windy conditions.
- Artists are required to represent their original work only.
- The event runs from 10 am-5:30 pm with set up beginning at 8am. Artists are expected to be present for the entire event.

## Application Instructions:

- 2) Application fee (non-refundable):
  - \$100.00 for non AGC Artist Members
  - \$25.00 for AGC Members (Member dues must have been paid by Dec. 31st 2016.)
